
Power Apps for many use cases

Jansen AG has been using Microsoft's cloud technologies for a long time - a strategic decision that is lived in the company. The Power Platform is an important part of this strategy. The approval app is a classic IT use case for an employee, who wants to install software locally. For that, the user needs administrator rights, which he or she does not

tion Authorisation App" developed by novaCapta, which has implemented a two-stage approval process with the Power Platform. The first stage is the approval by the respective superior, the second stage is the approval of This is more efficient and saves clicks. novaCapta has also improved the authorisation app in terms of security: an additional authorisation query is carried out in the background, which checks whether the person logged in is allowed to edit this query at all. If an employee who is not authorized clicks on the link, the fields

cannot be edited.

"We benefit greatly from novaCapta knowledge," says Rebekka John. "The next apps are in the planning stage and are based on the principle of achieving the greatest possible benefit with minimum effort".
